
# **Property Tax**

Property taxes fund Education, the County of Peterborough and the Township. For residential ratepayers, the taxes paid to the Township are shared as follows:

Education 13%

County 32%

Township 53%



### **2024 Final Tax Bill Due Dates**

Friday July 26 & Friday Sept 27

Please note that a 1.25% penalty is imposed on unpaid balances on the 1st day of each and every month the default continues. Township staff do not have the authority to waive penalties.

#### Flat rates for Area Services on the Tax Bill

Annual Rate for:

- Curbside Pick Up (island and vacant lands excluded)
   \$55.00 per household and/or unit
- ✓ For owners of properties served by the Municipal Water Systems in Keene and Stewart Hall
   \$ 2,311.00 per household
- ✓ For Burnham Meadow property owners served by sewer systems: \$1,185.00 per household and/or unit
- ✓ Swimming Pool Surcharge \$ 117.00 per household in Keene and Stewart Hall
- ✓ Street Light Service Areas are rated by community area

Pre-authorized payment plans are available. If paying through internet banking, please allow 2-3 business days for us to receive payment to ensure your payment is not received late. You can also pay by credit card online through Paymentus.

Property Tax Grant for low-income seniors and persons with disabilities If you are a senior on the guaranteed income supplement or a person on a disability pension, you may qualify for a property tax grant. This grant covers permanent year round residences only. The County of Peterborough runs the program and it is administered by the Township. Proof of eligibility is required. Applications will be available on our website and in the office by approximately the end of September and must be submitted by November 15, 2024.

# **Budget 2024**

The 2024 **Total Township Budget** is \$13,438,654 which includes operating costs of \$8,521,584, capital plan projects of \$3,089,700 and \$1,827,371 provision for reserves to fund future infrastructure replacement. The **2024 Total Township Tax Levy** is \$7,239,352 with the balance funded through grants, user fees, development charges, reserve transfers and other revenue. This translates into a 2.97% increase in the Township tax rate. Each property is impacted differently based on the assessed value determined by the Municipal Property Assessment Corporation. Assessment increases are generally phased in over four years. For more information about assessment, please check out the MPAC website at <a href="https://www.mpac.ca">www.mpac.ca</a>. # **Building Department**

The building department is now utilizing the on-line Cloud Permit and Planning process to make the application and communication process more modern. A direct link to make an application through cloudpermit can be found on the Township website.

When considering a renovation, alteration, change of use, addition, new build, swimming pool, or, adding a secondary suite please call the Building Department at 705-295-6852 ext 233 to discuss the details of your project. We can answer any questions that would relate to applying for a building/renovation permit, provide the requirements for drawings, zoning, septic system setbacks, and Otonabee Conservation Authority for your application.

#### Building permits are required for the following:

- Additions, renovations, or alteration to a house, adding a secondary suite
- New industrial, commercial, and institutional buildings
- Change of use to existing buildings
- Making new openings for larger windows/doors
- Swimming pool
- Decks, fireplaces, adding plumbing fixtures, finishing a basement.
- Tents greater than 60 sq m (646 sq.ft.) in ground area (including multiple tents).
- Demolition of part or whole structures

#### Building permits are not required for the following:

- Roof re-shingling
- Replacement of existing, same-size windows and doors, hot water tank, furnace
- Replacing exterior siding
- Minor Interior renovations such as replacing cabinetry
- Accessory shed under 15 sq.m (161 sq.ft.) but must conform to zoning setbacks
- Demolition of a building located on a farm

# **Development Charges for 2024**

The 2024 phased in Township Development Charges under By-Law No. 2020-60 are as follows:

Residential - All dwelling units \$11,117

Non-Residential – \$4.53/square foot

# **Fire Safety**

#### Smoke & Carbon Monoxide (CO) Alarms

Do you know that smoke and carbon monoxide (CO) alarms expire? You need to replace smoke and CO alarms according to manufacturer instructions. Replacing alarms is required every 7-10 years, depending on the alarm type.

If your alarms do not have a sticker indicating a replacement date, it is likely due for replacement. These replacement identifying stickers have been placed on alarms for over 10 years now.

When replacing alarms remember that you are required to replace your alarms with the same level of protection that was installed at the time of construction of your home.

For example, if you have hard-wired interconnected alarms with strobe lights, you cannot go to a stand-alone battery alarm. You must replace the alarms with the same level of protection that is existing.

**Alarm Door-to-Door Checks** 

Members of the Otonabee-South Monaghan Fire Department, identifiable in uniform and with photo id, will be heading out to knock on some doors between June 15 and September 15, to conduct the door-to-door remote area smoke alarm program.

If they are in your area and knock on your door, please be reminded that this is a service for your benefit. Smoke alarms save lives, but only if they are operating and installed in the proper locations within your home.

Ensure you have your smoke & CO alarms working and installed properly, even if we do not knock on your door this year. Smoke alarms are to be located on every level of your home and outside of all sleeping areas.

**Carbon Monoxide (CO) Alarms** are to be located adjacent to all sleeping areas in homes with fireplaces, fossil-fuel burning appliances or that have an attached garage.

When replacing alarms, consider using combination smoke/CO alarms with a 10-year sealed battery to save you from having to change batteries each year.

Be reminded that these alarms still need to be tested monthly. Please contact the Fire Department Administration Office if you have any questions about your alarms or require assistance changing batteries or alarms

**Saved by the Beep** – Test your Smoke Alarm day is taking place on September 28, 2024. Smoke Alarms should be tested every month. Get in the habit of testing your alarms at the end of each month.

The week of Sept. 23, be sure to follow us on social media and the OSM Township website, as we promote this worth-while initiative in fire safety. And don't forget to test your smoke alarms on September 28th!



#### **Open-Air Burning**

Campfires do not require a burn permit in OSM Township. However, you are still required to follow the requirements of the open-air burning by-law #2022-50. This by-law can be found on the OSM Township website, or you can obtain a copy by calling the Fire Department Administration Office for a copy to be emailed to you.

When you are enjoying a campfire or recreational fire, please be reminded that the only burnable items are wood and wood by-products.

And please be mindful of the smoke and how it could be affecting your neighbours. If it is possible that the air is heavier than normal, preventing the smoke from clearing the area, and that it could be impacting someone nearby with a health issue or aversion to smoky air, please consider dousing the fire to mitigate the extra smoke until the air is lighter. Be reminded that burn barrels are not permitted in OSM Township.

Clear Garbage Bag Program. Thank you to all residents for helping to make this program a continued success. The Township is very pleased to report that since the launch of the program there has been a significant decline in waste generation and a huge increase in recycling. Garbage can be left at the curb or can be taken to the Drummond Line Transfer Station for a fee in the following ways: 1) in a clear bag in a garbage container; 2) in a clear bag; or 3) in an opaque small grocery size privacy bag to shield private items. Garbage must be at the road before 7:00am to avoid missing collection. For clear bag program details please see the Township website www.osmtownship.ca.

- 2. Sort your materials into 2 boxes, Containers and Papers.
  - Use as many boxes as needed, as long as Containers, and Papers are in separate boxes.
- 3. Keep recycling loose in Blue Boxes.
  - ✓ Bagged recycling will not be collected.
