**Application for a Minor Variance filed under the provisions of Section 45 of the *Planning Act*, R.S.O. 1990, as amended, to be heard by the Committee of Adjustment of the Township of Otonabee-South Monaghan.**

**PURPOSE AND EFFECT OF APPLICATION:**

Relief through a Minor Variance is requested from the following provisions of By-law No. 2010-65 of the Township of Otonabee South Monaghan:

- (1) To increase the Maximum Height for an Accessory Structure from 5.0 metres to 6.10 metres

The purpose of this Minor Variance application is to permit the development of one (1) accessory detached pole barn on the property.

The subject lands are currently zoned Rural Residential (RR) which allows for Accessory Structures to be 5.0 metres in height. The applicant is requesting to increase the maximum accessory structure height from the permitted 5.0 metres to 6.10 metres, presenting an overage of 1.10 metres to the requirement.

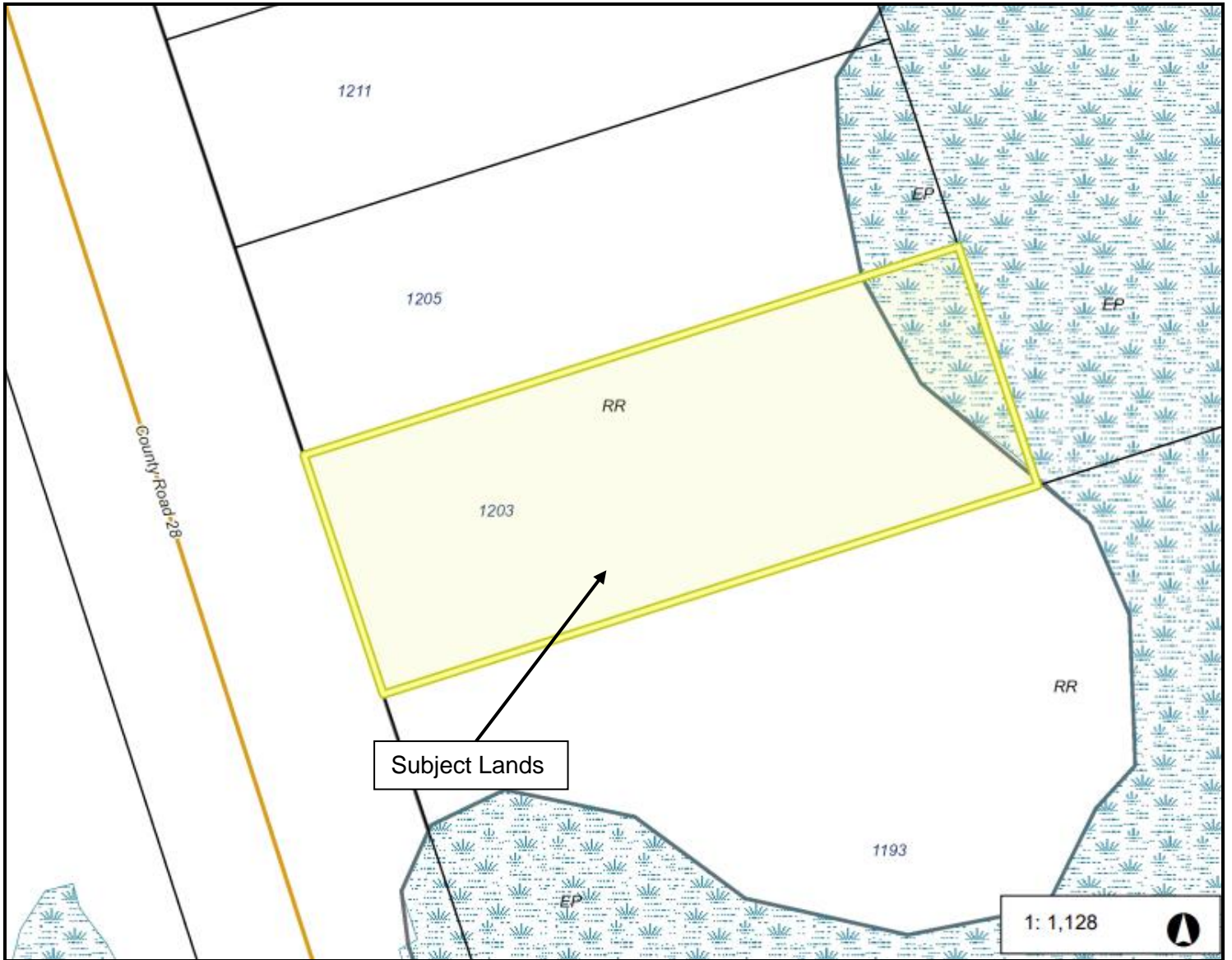
