### **NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING CONCERNING AN APPLICATION FOR A ZONING BY-LAW AMENDMENT**

**TAKE NOTICE** that the Council of the Corporation of the Township of Otonabee-South Monaghan has received a complete application for an amendment to the Township of Otonabee-South Monaghan Comprehensive Zoning By-law No. 2010-65 and is notifying the public in accordance with Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

**AND TAKE NOTICE** that the Council of The Corporation of the Township of Otonabee-South Monaghan will hold a public meeting on **Monday, February 10<sup>th</sup>, 2025, at 6:00 p.m.**, in the **Council Chambers, Township of Otonabee-South Monaghan Municipal Building, 20 Third Street, Keene, Ontario**, to consider a proposed Zoning Bylaw Amendment, pursuant to Section 34 of the Planning Act, R.S.O. 1990, c.P.13.

#### **Location of the Subject Lands**

The proposed Zoning By-law Amendment applies to a property that is located at Concession Long Island, Part Lot 12 in the South Monaghan Ward of the Township of Otonabee-South Monaghan. The subject lands are known as 126 Long Island. (Key Map below).

#### **Purpose and Effect of the Proposed Zoning By-law Amendment**

The proposed Zoning By-law Amendment is required as a condition of Consent approval for Application B-155-22 which proposes a technical severance- lot addition to the adjacent parcels.

The subject lands are currently zoned Limited Service Residential-2 (LSR-2) in By-law No.2010-65 of the Township of Otonabee-South Monaghan. The purpose and effect of the Zoning By-law Amendment is as follows:

- (1) Rezone the benefitting land from the Limited Service Residential-2 (LSR-2) Zone to a Site-specific Limited Service Residential-XX (LSR-XX) Zone in order to acknowledge the deficient lot area and frontage.

#### **Representation**

If a person or public body would otherwise have an ability to appeal the decision of the Council to the Township of Otonabee-South Monaghan to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body may not be added as a party to the hearing of an

appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Notwithstanding the above, subsection 34(19) of the Planning Act defines the parties that are eligible to appeal the decision to the Ontario Land Tribunal.

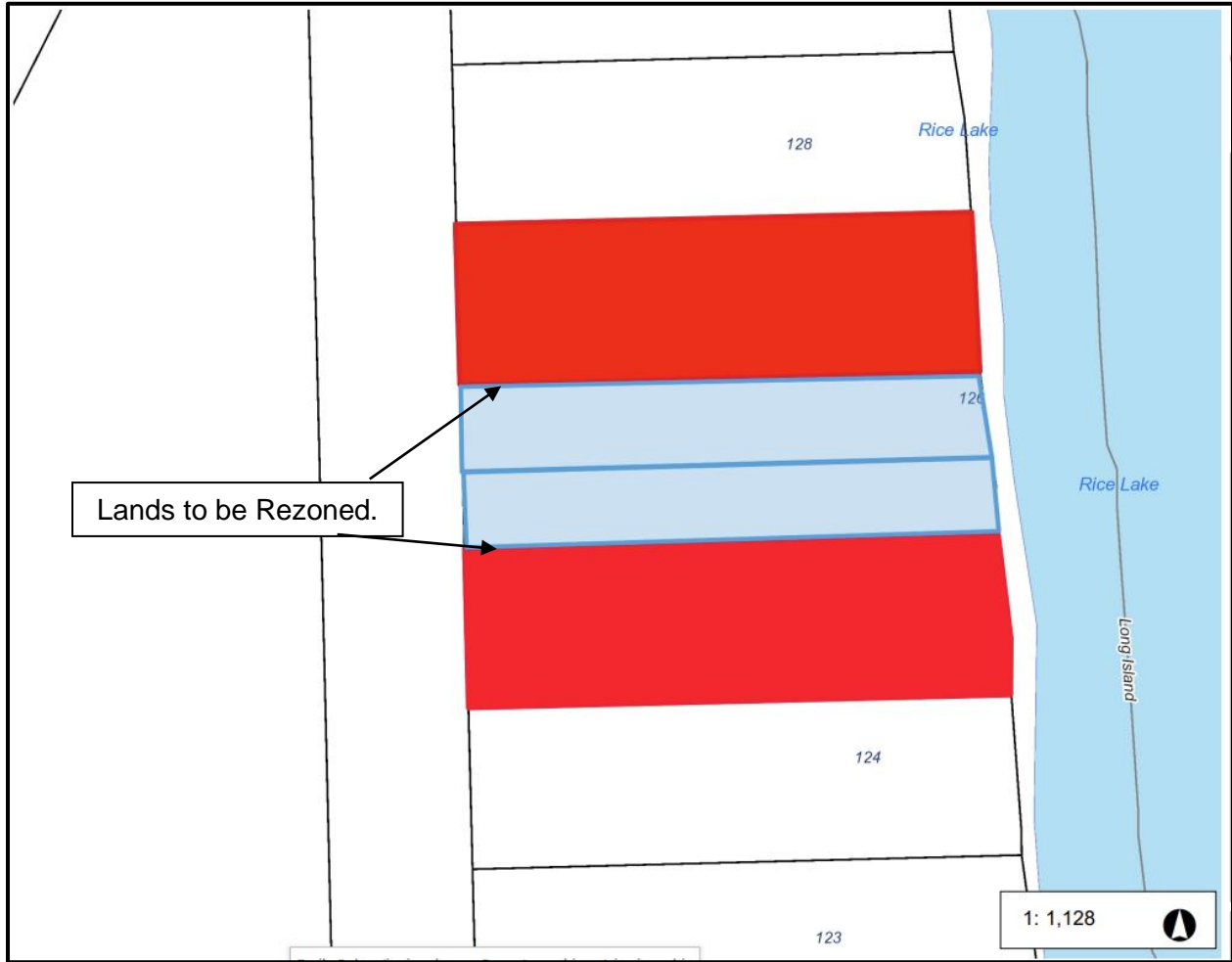
