NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING CONCERNING AN APPLICATION FOR A ZONING BY-LAW AMENDMENT

TAKE NOTICE that the Council of the Corporation of the Township of Otonabee-South Monaghan has received a complete application for an amendment to the Township of Otonabee-South Monaghan Comprehensive Zoning By-law No. 2010-65 and is notifying the public in accordance with Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

AND TAKE NOTICE that the Council of The Corporation of the Township of Otonabee-South Monaghan will hold a public meeting on **Monday, April 28th, 2025, at 6:00 p.m.**, in the **Council Chambers, Township of Otonabee-South Monaghan Municipal Building, 20 Third Street, Keene, Ontario**, to consider a proposed Zoning Bylaw Amendment, pursuant to Section 34 of the Planning Act, R.S.O. 1990, c.P.13.

Location of the Subject Lands

The proposed Zoning By-law Amendment applies to a property that is located at Concession 11, Part Lot 26 in the Otonabee Ward of the Township of Otonabee-South Monaghan. The subject lands are known as 2190 Burnham Line. (Key Map below).

Purpose and Effect of the Proposed Zoning By-law Amendment

The proposed Zoning By-law Amendment is required as a condition of Consent approval for Application B-58-24 which proposes one (1) residential severance.

The subject lands are currently zoned Rural and Environmental Protection in By-law No.2010-65 of the Township of Otonabee-South Monaghan. The purpose and effect of the Zoning By-law Amendment is as follows:

- (1) Rezone the severed land from the Rural (RU) Zone to Rural Residential (RR) Zone to permit a rural residential use and Environmental Protection (EP) to reflect the updated floodplain mapping from Meade Creek; and
- (2) Rezone the retained lands to increase the additional Environmental Protection (EP) Zone from the updated floodplain mapping of Meade Creek.

Representation

If a person or public body would otherwise have an ability to appeal the decision of the Council to the Township of Otonabee-South Monaghan to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body may not be added as a party to the hearing of an

appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Notwithstanding the above, subsection 34(19) of the Planning Act defines the parties that are eligible to appeal the decision to the Ontario Land Tribunal.

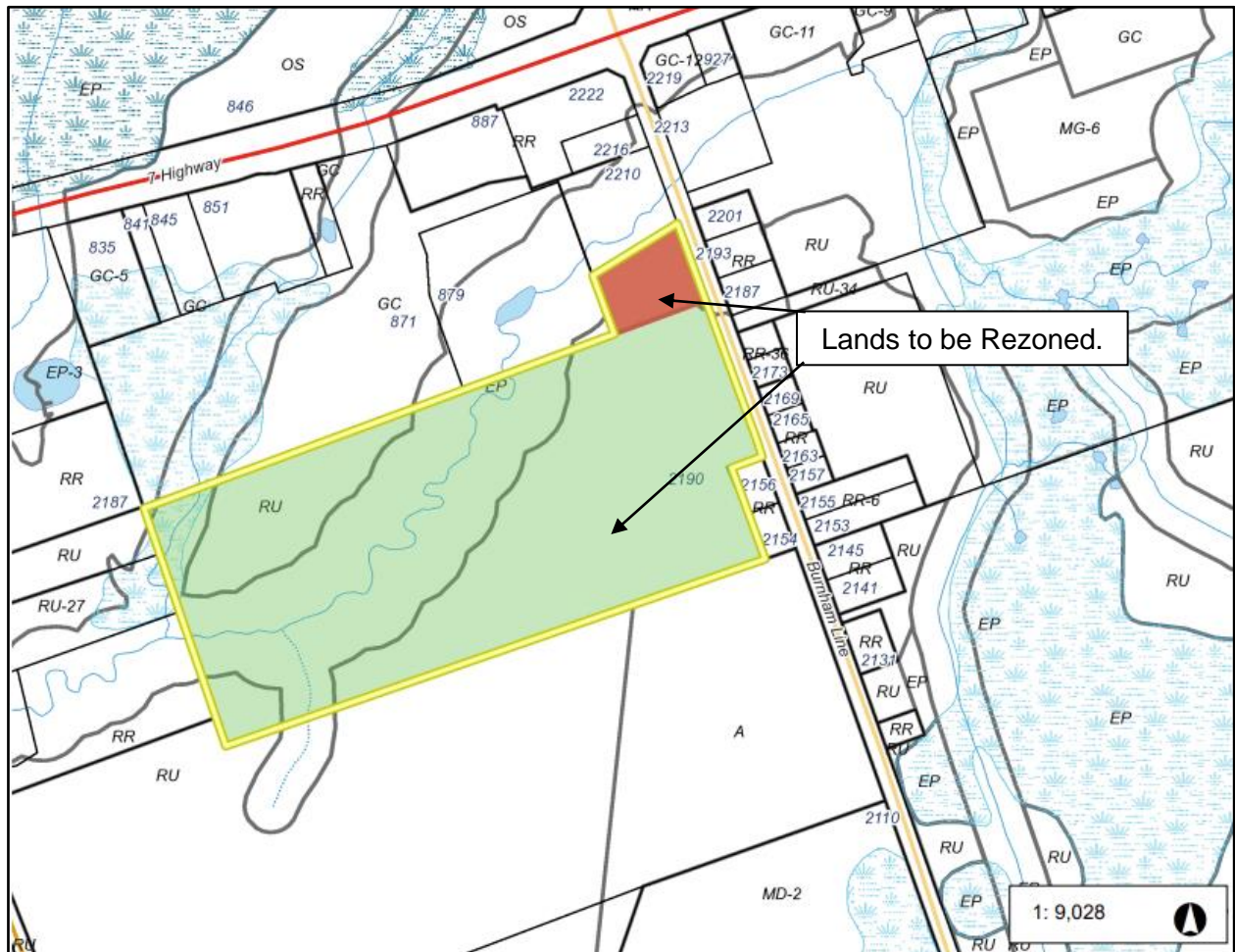
