### **NOTICE OF COMPLETE APPLICATION AND PUBLIC MEETING CONCERNING AN APPLICATION FOR A ZONING BY-LAW AMENDMENT**

**TAKE NOTICE** that the Council of the Corporation of the Township of Otonabee-South Monaghan has received a complete application for an amendment to the Township of Otonabee-South Monaghan Comprehensive Zoning By-law No. 2010-65 and is notifying the public in accordance with Section 34 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended.

**AND TAKE NOTICE** that the Council of The Corporation of the Township of Otonabee-South Monaghan will hold a public meeting on **Monday, August 12<sup>th</sup>, 2024, at 6:00 p.m.**, in the **Council Chambers, Township of Otonabee-South Monaghan Municipal Building, 20 Third Street, Keene, Ontario**, to consider a proposed Zoning Bylaw Amendment, pursuant to Section 34 of the Planning Act, R.S.O. 1990, c.P.13

#### **Location of the Subject Lands**

The proposed Zoning By-law Amendment applies to a property that is located at Concession 6, Part Lot 4 in the South Monaghan Ward of the Township of Otonabee-South Monaghan. The land is located along Atchison Road (Key Map below).

#### **Purpose and Effect of the Proposed Zoning By-law Amendment**

The proposed Zoning By-law Amendment is required as a condition of Consent approval for Application B-104-23 which proposes one (1) severance along Atchison Road.

The subject lands are currently zoned Agriculture (A) in By-law No.2010-65 of the Township of Otonabee-South Monaghan. The purpose and effect of the Zoning By-law Amendment is as follows:

- (1) Rezone the severed lands of Consent application B-104-23 from the Agriculture (A) Zone to Rural Residential (RR) Zone in order to permit the proposed residential use.
- (2) Rezone the retained lands from the Agriculture (A) Zone to Rural (RU) Zone.

#### **Representation**

If a person or public body would otherwise have an ability to appeal the decision of the Council to the Township of Otonabee-South Monaghan to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Otonabee-South Monaghan before the by-law is

passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

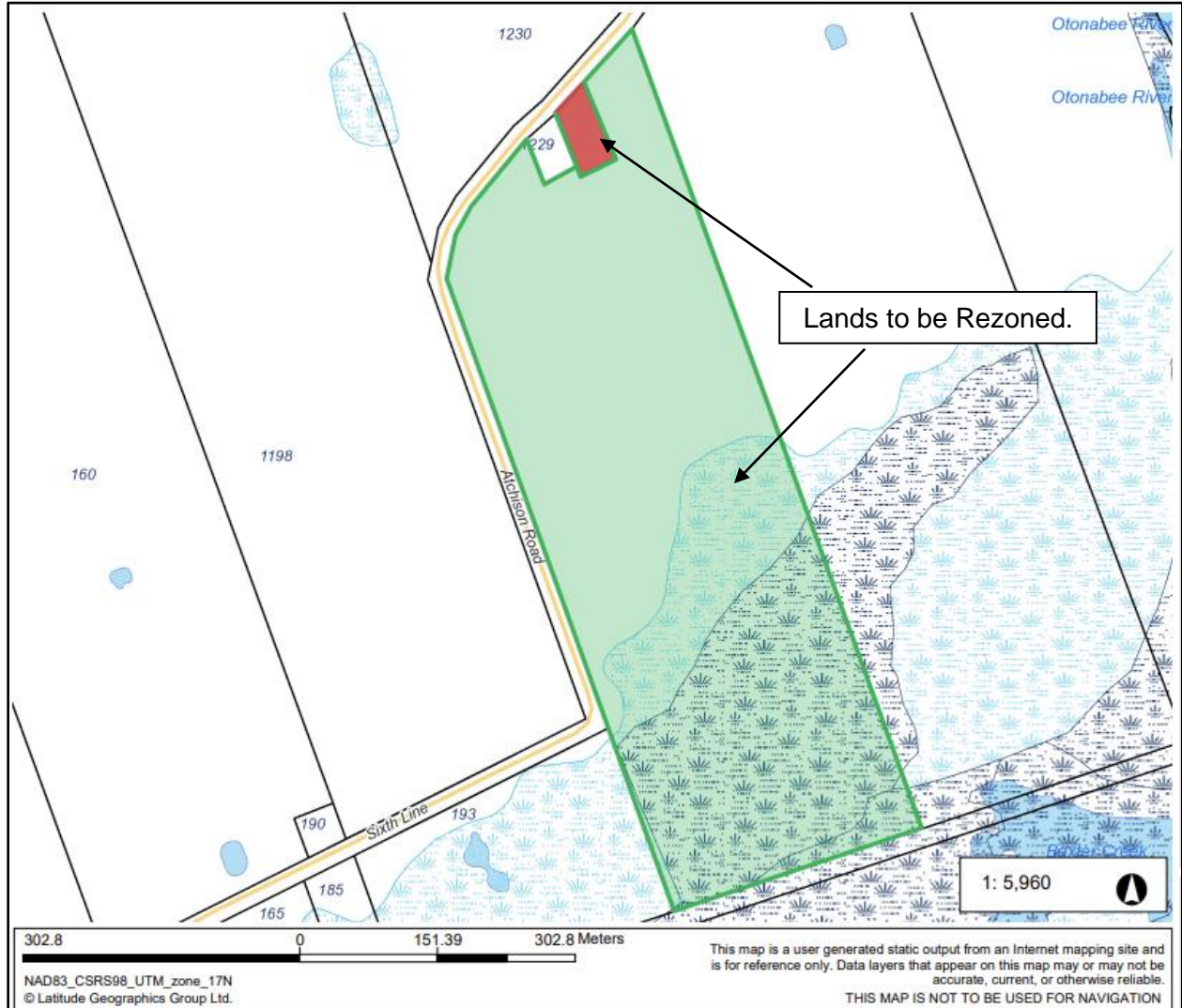
