## PURPOSE AND EFFECT OF APPLICATION:

Relief through a Minor Variance is requested from the following provisions of By-law No. 2010-65 of the Township of Otonabee South Monaghan:

(1) To increase the Maximum Ground Floor area of a Secondary Dwelling Unit from the required 70% of the Principal Dwelling to 80%.

The purpose of this Minor Variance application is to permit an addition onto the existing secondary dwelling on the property.

The subject lands are currently zoned Rural (RU) which permits Secondary Dwelling Units. The applicant is requesting to increase the Secondary Dwelling Unit Ground Floor Area from the permitted 70% of the Main Principal Dwelling to 80%, representing an overage of 10% to the requirement.


